REPORT OF THE STATUTORY MEETING OF MINISTERS IN CHARGE OF QUALITY IN ECOWAS COUNTRIES

19 - 20 October 2017

REPORT

1. INTRODUCTION

From October 19th to 20th, a statutory meeting of ministers in charge of quality was held in Niamey. This Ministerial Session aims to examine and validate:

- Three (03) draft ECOSTAND standards on agricultural products;
- Fourteen (14) draft ECOSTAND standards on food products;
- eight (08) draft ECOSTAND standards on chemicals products:
- twenty-three (23) draft ECOSTAND standards on buildings and building materials;
- two (02) draft ECOSTAND standards on electrotechnical products;
- three (03) draft ECOSTAND standards on tourism.

2. EXPECTED RESULTS

The Ministerial Session aimed at validating the fifty-three (53) draft standards submitted.

3. OPENING CEREMONY

The opening ceremony was chaired by The Minister of Industry of Niger republic, Mr Abdou Maman. It comprised four speeches.

The Delegate of the European Union in Charge of Affaires in Niger, Mr Bernard FRIEDLING congratulated the Theme Quality object of the meeting. He reminded the formulation and implementation of quality systems strengthening support programs in West Africa, whose objectives are to strengthen regional and commercial economic integration by creating a favourable environment that comply with the rules of the international trade and technical regulations. He reassured the *ECOWAS Commission and Member States of the full support of the European Union and wished full success to the meeting.

In his address, Mr. Ahmed HAMID, former Commissioner of ECOWAS in charge of Trade, Customs, Industry and Mines, Free Movement of Persons and Goods, welcomed the very fine course and the progress made in this long-term work. He recalled the stakes namely the emergence of our countries to have a place of choice in the international community. He reiterated the importance of continuing efforts to be closer to our companies, which often face difficulties in terms of isolation, technology, financial deficit and so on. He ended by thanking the audience and wishing full success in the Quality projects.

Mr Kalilou TRAORE Commissioner of ECOWAS in charge of Industry and Private Sector Promotion, on behalf of the President of the Commission, thanked the assembly for honouring the invitation to this Statutory Session of Ministers of ECOWAS. He expressed his gratitude to the national authorities of the Republic of Niger for hosting this important meeting. He recalled the evolution of the ECOSHAM program and the implementation of the Quality infrastructure and thanked his predecessor who led the launch of all these projects, during his mandate at the Commission. He praised the efforts of the technical committees whose results prove the effectiveness of the work in synergy. He reiterated his thanks to UNIDO, which is implementing the West Africa Quality System Program (WAQSP), and particularly to the European Union, which is funding to the tune of 12 million Euros. He recalled the availability of funds by the European Union for the second phase of the Quality Program last December, as well as the decision, within the framework of the 11th European Development Fund (EDF), to integrate the Quality aspects in the ECOWAS Regional Program on Value Chains. He recalled the major results achieved in the field of Regional Quality Infrastructure with the support of the PSQAO, as well as the progress made in the legal framework in the spirit of ensuring the operationality of the Infrastructure Scheme of Quality of ECOWAS. He ended by wishing full success for the work and by making an appointment for the next major Quality activities that the Commission will implement in the coming months.

The Minister of Industrial Development of the Republic of Niger, Mr. Abdou MAMAN, on behalf of his Excellency Mr. ISSOUFOU MAHAMADOU, President of the Republic of Niger, Head of State and Mr.

BRIGI RAFINI, Prime Minister Head of Government and on behalf of the Niger people, wished the warm welcome to the African soil of Niger to all its counterparts and participants. He emphasized that quality issues are decisive issues in the preservation of the health of our populations and the protection of the environment. He reminded that our sub-region has suffered so much and still suffers from the lack of tools not only to produce in a harmonized way the various goods and services, but also and above all to determine and control the intrinsic characteristics of certain products with dubious quality that are imported into our space. He also said that, it is important and even a necessity to ensure the conformity of our products and it is essential to ensure the conformity of our products to make them more competitive for export. Note that, it is in this context that Niger is committed to the implementation of a standards compliance verification program which is based on national, regional and international standards. He recalled that it was also in Niamey that the draft Regional Quality Policy Document (ECOQUAL) and the draft document on Model and Procedures for the Harmonization of ECOWAS Standards were validated in October 2012. He paid a well-deserved tribute to the ECOWAS Commission and to the technical and financial partners whose commitment and support of various orders made possible the implementation of the different policies. He ended his remarks by expressing his sincere thanks to the European Union for funding the WAQSP, to UNIDO for its implementation and to the team of experts who did a remarkable job. He then, declared open the work of the meeting of Ministers in charge of Quality of ECOWAS.

2) Review, validation of report findings

After presenting the list of standards and their impact on the economy, the health of populations and environment of the ECOWAS region, the Statutory Meeting of Ministers in charge of Quality:

- a) validates the fifty-three (53) ECOSTAND standards and,
- b) Recommends them for the next Council of Ministers of ECOWAS for adoption.

However, concerning the standard on Turpentine, the TMC reminded that a practical usage guide for this product should be elaborated in order to cope with the concerns of the member states.

In a spirit of sharing and complementarity, Mali has expressed its wish to provide the secretariat of the THC5 (Electro-technique). The TMC President promised to pay particular attention to any written request to this effect.

In addition, the meeting also made recommendations, which are set out in point 8 of this report.

7. West Africa Quality System Programme: state of the Progress

Mr. Aka KOUASSI, Chief Technical Advisor (PTC) of the WAQSP presented the status of progress of the implementation of the Program in its financial and technical aspects. He mentioned the main results of the program and the activities carried out.

He mentioned the next steps of the program and presented the challenges and recommendations. At the end of the Presentation, the CTP answered the various questions asked by the participants.

8. Recommendations

The Meeting of Ministers in charge of Quality recommends:

To the ECOWAS Commission

- 1. Finalize the logo design for foods products fortified with micronutrients
- 2. make regulations for the compulsory fortification of vector foods which are subjected to harmonized standards and high consumption in the Community area;
- 3. Make all necessary arrangements for the translation into the three official languages of ECOWAS (English, French, Portuguese) any document produced as part of ECOSHAM's harmonization of standards;

- 4. Support the States in seeking funding for action plans linked to their national quality policy;
- 5. Make all necessary arrangements with UNIDO's technical partner for organizational improvement, logistics, technical and statutory meetings.

To Member States

- 1. Increase the involvement of the private sector in standard harmonization work;
- 2. Make reference, to ECOSTANDS harmonized standards in the specifications of the public contracts and the public order as much as possible;
- 3. Involve National Codex Alimentarius Committees in the work of harmonization of standards in the agri-food sector;
- 4. Adopt, National Quality Policies that were technically validated for countries which have not done it yet.
- 5. Encourage countries to reinforce institutional policies to check the conformity standards

9. Adoption of the report of the meeting

The report of the meeting was considered and adopted unanimously as amended.
