### 7. Recommendations

The CCCA recommended to ECOWAS Commission:

- At the place of "Resignation", put "Replacement": The replacement of each member of the community committee can be done by addressing a signed letter from country/organization to the ECOWAS commissioner who will notify the President of CCCA (Article 12)
- o the duration of the mandate of community committees members can be renewable once as for the president and vice-president (Article 3, N°1).
- o The enhancement of the implementation of the following activities:
  - Supporting for the development of the business plan should starts early in March 2018,
  - Recruitment of the officer of the conformity assessment secretariat to be done by the end of March 2018,
  - Start early the promotion of the ECOWAS brand in January 2018.



- Adopting the general rules of management of the regional brand of conformity to ECOWAS standards
- o Adopting the architecture for the rules of products certification
- Adopting the architecture regarding the rules of mandating certification bodies
- Ensure the technical validation of records of entrustment of the national standards bodies for the allocation of the mark of conformity with regional standards
